## Notes on Formal Photos:

Formal posed photos usually include various combinations of the bride, groom, wedding party members, and immediate family members. Posed formals may even include extended family members and close friends. Posed formals may be taken either just before or just after the ceremony. Normally, they are taken immediately after the ceremony. Sometimes, however (to save time), the bride, groom and family will decide to do these photos before the ceremony (usually at least 1 ½ to 2 hours before the ceremony).

How much time should be allowed for formal photos? A quick set of formal photos may be taken in as little as 30 to 45 minutes. An extended session may last from 45 minutes to 1.5 hours. Of course, it depends on the size of the wedding party and the number of family members and friends that it may be desired to include as part of the formal photo session.

It's always a good idea for the bride and groom to make a specific list of all of the family members (or family groups) of whom they'd like to have photos taken. This assists not only the photographer, but also helps the family sort out exactly what their formal photography needs will be. Such a list also helps to speed up the process of taking the formal photos, so that there is less time taken in making last-minute decisions on whom to include in those photos.

## WEDDING PHOTOGRAPHY CONTRACT

A Contract is entered into on this day of \_\_\_\_\_, 2008, between Deeter Photography (studio) and \_\_\_\_\_(client/s) for wedding photography services to be provided on the day of \_\_\_\_\_, 200\_. The specific terms of this contract are set forth in the following sections.

### I. PHOTOGRAPHY SERVICES AND FEES

The following photography services are to be provided to the client by Deeter Photography for the indicated fee/s:

The client understands the total amount of fees listed above must be paid in full one week before the day of the wedding. The client agrees this studio is the exclusive official photographer retained to perform the photography services described in this contract. In the event of a cancellation of the wedding and /or contract, the following amounts shall be retained by the studio:

- a) Cancellation after signing of the contract but before three (3) months prior to the wedding: \$250.00 of the original retainer fee paid by the client.
- b) Cancellation on and after three (3) months prior to the wedding. The \$500.00 retainer fee paid by the client.

### II. ORDERING AND RECEIPT OF PHOTOGRAPHS

Normal delivery time on the finished order will be sixty (60) to ninety (90) days after the date of the order, or longer depending on supplier deliveries and weather conditions.

All finished orders/must be paid in full and picked up within 30 days of notification. Orders are subject to a 5% surcharge on the remaining balance after 30 days of notification. The client understands that the studio reserves the right to use the images for display, publications or other purposes. The client further understands that all photographs purchased from this studio are copyrighted material and MAY NOT BE COPIED OR REPRODUCED IN ANY MANNER without the express consent of Deeter Photography.

### III. LIMITATION OF LIABILITY

The studio uses the utmost care with the respect to the exposure, care and delivery of photographs. However, in the event the studio fails to comply with the terms of this contract due to any event or act outside the control of the studio, the studio's liability is limited to refund of any retainer fees paid by the client.
